A BILL

To amend title III of the Public Health Service Act to direct the Secretary of Health and Human Services, acting through the Director of the National Institute for Occupational Safety and Health shall conduct research on programs to educate workplace professionals on the prevention of impairment from the use of cannabis, opioids, and other drugs, and the risks resulting from individuals working while impaired, and for other purposes.

2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. IMPAIRMENT PREVENTION, RECOGNITION AND**
4 **RESPONSE TRAINING.**

5 Part P of title III of the Public Health Service Act
6 is amended by inserting after section 399Q (42 U.S.C.
7 280g–4) the following:

8 **“SEC. 399Q-1. IMPAIRMENT PREVENTION, RECOGNITION**
9 **AND RESPONSE TRAINING.**

10 “(a) IN GENERAL.—Not later than 12 months after
11 the date of the enactment of this section, the Secretary,
12 acting through the Director of the National Institute for
13 Occupational Safety and Health (referred to in this sec-
14 tion as the ‘Secretary’), shall conduct research on pro-
15 grams that includes the elements specified in subsection
16 (b) to educate employers, workers, and relevant workplace
17 populations on—

18 “(1) the prevention of impairment from the use
19 of cannabis, opioids, and other drugs; and

20 “(2) the safety risks resulting from individuals
21 working while impaired from the use of cannabis,
22 opioids, and other drugs.

23 “(b) WORKPLACE TRAINING PROGRAM.—Not later
24 than 12 months after the date of the enactment of this
25 section, the Secretary shall, in consultation with a national

1 nonprofit organization with relevant expertise, develop a
2 workplace training program to be made available to full-
3 time and part-time employees and individuals employed by
4 a State or the Federal Government, which covers the fol-
5 lowing elements of impairment from the use of cannabis,
6 opioids, and other drugs:

7 “(1) The impact of impairment from the use of
8 cannabis, opioids, and other drugs on safety on the
9 job.

10 “(2) The importance of preventing, recognizing
11 and responding to impairment.

12 “(3) The role of various workplace professionals
13 when recognizing and responding to perceived im-
14 pairment from the use of cannabis, opioids, and
15 other drugs.

16 “(4) Common signs and symptoms of impair-
17 ment from the use of cannabis, opioids, and other
18 drugs.

19 “(5) The steps to respond to perceived impair-
20 ment.

21 “(6) Common workplace impairment prevention
22 measures.

23 “(7) Guidance on related workplace policies and
24 information on relevant laws and regulations.

1 “(c) EMPLOYEE AND EMPLOYER DEFINED.—In this
2 section, the terms ‘employee’ and ‘employer’ have the
3 meanings given such terms in section 3 of the Occupa-
4 tional Safety and Health Act of 1970 (29 U.S.C. 652).”.
