FROM ABIGAIL

My chief responsibility is to listen to the Virginians I represent, act on their concerns — and then get things done.

Throughout 2022, I heard from Virginians who were facing high costs — whether at the grocery store, the gas pump, or the pharmacy counter. During meetings and town halls, I also heard concerns about keeping our children, neighbors, and communities safe. Virginians spoke with me about the importance of growing our economy, supporting our Veterans, defending our rights, and so much more — all while responding to the challenges of rebuilding from the COVID-19 pandemic, addressing workforce shortages, and grappling with the impacts of the Russian invasion of Ukraine. Thank you for sharing your views on these issues with my office over the past year.

In this end-of-year report, I hope you'll learn more about the work we accomplished for Virginia in 2022. And I hope you'll also get a sense of my priorities going forward in 2023.

This year, I was proud to vote to pass legislation — signed into law by the President — to lower prescription drug, insulin, and vaccine costs for Virginia's seniors. I'm also proud that the President signed into law one of the largest expansions of Veterans healthcare and benefits in history — reforms that are long overdue, particularly for our Vietnam, Gulf War, and post-9/11 Veterans.

In 2022, the President signed into law multiple bipartisan bills that I was proud to lead.

These efforts include my work to strengthen our response to fentanyl coming through our borders, combat addiction here in the Commonwealth, tackle climate change, and support Virginia's crop and livestock producers. Additionally, the President signed into law my legislation — that I worked on with both Democrats and Republicans — to protect the retirement benefits of police officers and firefighters, as well as my bill to increase job opportunities for Virginia's Veterans.

As we look ahead to next year, I also want to make sure you know that one of my responsibilities is assisting Virginians who are having issues getting a timely response or fair treatment from a federal government agency.

In 2022 alone, my team returned more than \$16.6 million dollars to Virginians. And since first taking office, our team has returned nearly \$28 million dollars to residents of Virginia's Seventh District — including through IRS, Social Security (SSA), and Veterans Affairs (VA) casework. We are always here to help.

It's a tremendous honor to serve Virginia's Seventh District in the U.S House.

In Congress, I'm working to lower costs, support local jobs, and keep Virginia competitive — because these are the priorities of the Virginians I serve. I'm also focused on protecting the rights of all Virginians — and I'm committed to curbing gun violence in our communities, bringing people together, and strengthening our national security.

DELIVERING FOR VIRGINIA

Abigail has worked directly with Virginia leaders to bring the concerns of Seventh District communities to Congress and get federal support for local priorities. Her work with local leaders has focused on keeping Virginians safe, rebuilding our physical infrastructure, expanding healthcare and treatment services, creating new jobs, and fostering economic growth.

In March 2022, President Biden signed into law funding for 10 Virginia projects that Abigail successfully secured — totaling more than \$6.4 million now headed to Virginia's Seventh District.

Abigail collaborated with county officials and community leaders to solicit these Community Project Funding requests, move these projects forward, and ensure they were included in the final end-of-year funding deal.

WHAT THEY'RE SAYING:

AMELIA COUNTY

\$375,000 for a new office of the Clerk of the Circuit Court in Amelia County, to improve safety for citizens and public employees.

Abigail Announces \$1.5 Billion for Virginia's Economy Through Bipartisan Infrastructure Law

After strongly advocating for this legislation, participating in negotiations, and highlighting the benefits of the bill for Virginia, Abigail voted last year to pass the bipartisan Infrastructure Investment and Jobs Act. And throughout 2022, she announced new investments coming to Virginia thanks to the bipartisan infrastructure law — including more than \$1.5 billion announced in October 2022 through the Federal Highway Administration. To date, more than \$4.3 billion in bipartisan infrastructure law funding has been announced for Virginia — with more than 110 specific projects already identified for funding. (WTOP, 4/1/2022; Rep. Abigail Announces More than \$107 Million for Virginia Bridge Repair & Construction through the Bipartisan Infrastructure Law

In early 2022, Abigail announced an award of more than \$107 million from the U.S. Department of Transportation (USDOT) for bridge repair and replacement across Virginia — home to approximately 577 bridges in need of repair. USDOT launched the largest bridge formula program in American history — made possible by the bipartisan infrastructure law. (Rep. She was joined by local Boards of Supervisors members, mayors, education leaders, rural electric cooperatives, first responders, and industry leaders — as well as White House Senior Advisor and Infrastructure Coordinator Mitch Landrieu and the NTIA's Special Representative for Broadband Andy Berke. Abigail announced in April 2022 that Virginia will receive \$165,786,199 in direct investment to assist with reducing traffic congestion and

This funding was made possible through the RAISE grant program, which was signed into law as part of the bipartisan infrastructure law. Abigail Leads the Charge to Ban Members of Congress from Trading Individual Stocks

Throughout 2022, Abigail continued to spearhead the movement to ban Members of Congress from trading individual stocks. Her bipartisan TRUST in Congress Act — which would effectively ban lawmakers, their spouses, and their dependent children from buying and selling individual stocks — gained more momentum in both parties than ever before. Additionally, she successfully pushed for a U.S. House hearing on the stock trading issue, leading to further momentum going into the next Congress. Abigail also called out congressional leadership in both parties for stalling legislation that would finally get this reform done before the end of the year. Abigail Introduces Bipartisan Bill Requiring Members of Congress to Electronically File Public Financial Disclosures

Currently, U.S. Representatives and U.S. Senators have the option of completing their public financial disclosures — including annual required reporting and periodic transaction reports — either by hand or electronically. However, recent reporting has shed light on how the current disclosure system leads to nearly or completely illegible paperwork filing of Members of Congress's financial disclosures. To increase transparency, Abigail introduced bipartisan legislation — the Easy to READ Act — to require Members of Congress to file their public financial disclosures electronically. Abigail Presses IRS to Clear Backlog & Improve Customer Service

As the 2022 tax filing season began, Abigail led multiple bipartisan and bicameral efforts urging the IRS to take immediate actions to reduce its massive backlog, improve its customer service, and reduce disruptions for Virginia taxpayers. She highlighted the challenges Americans are facing in their day-to-day interactions — including many Virginians still waiting on their 2020 tax returns to process. (Rep. Abigail Votes to Lower Drug Costs for Virginia Seniors, Give Medicare Power to Negotiate

Abigail has long worked to cap insulin costs and give Medicare the power to negotiate drug prices. In August 2022, she voted to pass the Inflation Reduction Act, which will lower drug costs for Virginia seniors. The law caps seniors' out-of-pocket prescription costs at \$2,000 per year — and it caps insulin copays for Medicare beneficiaries at \$35 per month. Additionally, it provides Virginia seniors with free shingles vaccines. U.S. House Passes Abigail's Legislation to Lower Grocery & Gas Costs, Fight Inflation

In June 2022, a bipartisan majority of the U.S. House voted to pass Abigail's legislation — the Lower Food and Fuel Costs Act — to lower costs at the grocery store, reduce gas prices, strengthen food supply chains, and increase competition in the American meat industry. Additionally, her bill would combat rising fertilizer prices and increase the availability of higher ethanol blends and other biofuels in Virginia and across the country. (Rep. The U.S. Senate Agriculture Committee voted in June 2022 to advance Abigail's bipartisan and bicameral legislation — the Meat and Poultry Special Investigator Act — to help lower food prices and tackle anticompetitive practices in the American

meat and poultry industries. Her legislation focuses on preventing shortages, enforcing America's anti-trust laws, and holding bad actors in the meat industry accountable for monopolistic practices — all while supporting Virginia's smaller livestock producers. During the event at Germanna Community College's Culpeper campus, Abigail and the President were joined by several Virginians who have been negatively impacted by rising drug prices, as well as HHS Secretary Xavier Becerra. Among those in attendance was Joshua Davis, a 12-year-old Virginian with type 1 diabetes from Midlothian who introduced President Biden. Throughout 2022, Abigail continued her efforts to protect the Federal 340B Drug Pricing Program and preserve discounted drugs for Virginia seniors and families — particularly those in rural and underserved communities. This year, Abigail pressed the Biden Administration to take immediate action against drug manufacturers that refuse to comply with the 340B laws on the

books. Additionally, she led a bipartisan group of her colleagues in speaking on the floor of the U.S. House in support of the federal 340B Drug Discount Program. In December 2022, President Biden signed into law Abigail's Growing Climate Solutions Act
— which will break down barriers for farmers, ranchers, and foresters interested in participating in carbon markets and embracing climatesmart practices. The law is supported by a wide range of farm, environment, and industry organizations in Virginia — including the Virginia Farm Bureau Federation, Chesapeake Bay Foundation, and Virginia Agribusiness Council. Abigail Secures Major Investment in Voluntary Conservation Programs for Virginia Farmers

As the Chair of the U.S. House Agriculture Committee's Conservation and Forestry Subcommittee, Abigail led several efforts in 2022 to support and expand successful, voluntary conservation programs that are good for the land and good for farmers' bottom lines. As part of the Inflation Reduction Act, Spanberger spearheaded a \$20 billion investment in American agriculture and conservation through provisions from her bipartisan REAP Improvement Act and Climate Stewardship Act. These investments — signed into law by the President — marked the largest investment in sustainable agriculture since the creation of USDA's conservation programs following the Dust Bowl. Throughout 2022, Abigail worked to help Virginia schools keep providing meals to students and mitigate the impacts of inflation on school districts. After she pressed U.S. House leadership in both parties to act with urgency to extend key school meal waivers ahead of a critical deadline, an overwhelmingly bipartisan majority of the U.S.

House voted to pass legislation that would protect access to school meals. The legislation — the Keep Kids Fed Act — was soon signed into law by President Biden. Following Dobbs Decision, Abigail Takes Action to Protect Women Across the Country

After the U.S. Supreme Court overturned Roe v. Wade, Abigail took immediate actions to prevent further steps that undermine the right to privacy and a woman's right to choose. In July 2022, she voted to codify into federal law the right for Americans to access contraception — as well as voted to defend the right of Americans to travel across state lines to seek lawful abortions. President Signs into Law Abigail's Bipartisan Bill to Protect Retirement Benefits for Police Officers & Firefighters

After hearing concerns directly from Virginia's retired police officers, Abigail successfully secured the passage and signing into law of her bill to protect key tax benefits for retired public servants. Her Wally Bunker HELPS Retirees Improvement Act removes the requirement that pension fund distributions must go directly to the insurer to be eligible for tax-free status — and it makes sure that retired first responders can access a critical tax benefit to help cover health and long-term insurance. These provisions unfairly reduce Social Security benefits for thousands of Virginians who devoted their careers to public service — including police officers, firefighters, federal employees, and teachers. Abigail's Social Security Fairness Act gained more than 300 cosponsors in the U.S. House, showing clear support from Democrats and Republicans alike for fixing this issue of fundamental fairness. In December 2022, President Biden signed into law Abigail's Summer Barrow Prevention, Treatment, and Recovery Act — major legislation to support programs that combat substance use disorder and addiction in Virginia and across the country. This law is named in memory of Summer Barrow, a young Virginian who died of a fentanyl overdose in January 2020. The law provides \$900 million for programs that focus on overdose prevention, first responder training, co-prescribing, and alternatives to opioids in emergency rooms. Abigail introduced the legislation in March 2023 alongside Summer Barrow's family — as well as Virginia law enforcement leaders, community organizations, and recovery advocates. In December 2022, President Biden signed into law her bipartisan legislation — the Securing America's Borders Against Fentanyl Act — requiring the U.S. Department of Homeland Security to focus on developing more effective ways to target and detect illicit fentanyl coming through our southern border.
